BASE DATA DEVELOPMENT DATA SOURCES AND ADJUSTMENTS

- Due to the low credibility of the MLTCOR Mandatory population data in the ROS regions, the Existing population data was used with an acuity adjustment for the Mandatory population in these regions.
- For FY2016-17, the ROS regions were divided into 3 individual regions (Mid-Hudson/Northern Metro, Northeast/Western, and Upstate) to eliminate the need for geographic factors.

BASE DATA DEVELOPMENT MANDATORY POPULATION ADJUSTMENTS

- Acuity and managed care savings adjustments applied to Mandatory population data reflect
 - Additional savings opportunities in New York City (NYC) Area
 - Acuity differences between Mandatory and Existing population base data for ROS regions
- Table below displays impact to total medical services for the Mandatory population at the best estimate for these adjustments

 Final base PMPMs for Existing and Mandatory populations were blended into a single combined base data PMPM based on enrollment

RATE-SETTING ADJUSTMENTS PROGRAM CHANGES

- Wage Parity
 - To develop the program change adjustment applied to rate, the FY2016-17 Target MLTC
 Hourly Worker Cost was compared to CY 2013 MLTC Base Hourly Rate
 - The table below summarizes these components and the development of the Raw Wage
 Parity Program Change Adjustment

RATE-SETTING ADJUSTMENTS PROGRAM CHANGES

- Wage Parity
 - The Raw Wage Parity Program Change Adjustment was prorated for two aspects:
 - Ensure only Personal Care Aide and Home Health Aide services portion of the total Personal Care and Other Home Health categories of service are increased for Wage Parity requirements.
 - As Wage Parity requirements were effective March 1, 2014, 10 months of the base data (March 1, 2014 through December 31, 2014) already reflect Wage Parity requirements and the unit cost for that time period does not need to be adjusted.

OTHER ADJUSTMENTS NHT ADD-ON

- Developed using projected FY2016-17 regional enrollment to calculate regional average provided by DOH.
- Will be calculated once for entire contract period.
- Illustrative plan payment rate example on calculation of NHT add-on is shown in the table below:

FY2016-17 RATE UPDATE CONSIDERATIONS MINIMUM WAGE

- Minimum Wage rates are scheduled to increase each year on 12/31 until they reach \$15.00 per hour.
- Minimum Wage updates are scheduled for December 31, 2016 and will impact October 2016 through March 2017 rates
 - NYC Metro Minimum Wage will increase from \$10.00 to \$11.00 on December 31, 2016
 - Apply adjustment to reflect hourly worker cost increase for Personal Care Aide and Home Health Aide services in NYC Metro based on State analysis
- If additional Minimum Wage adjustments are needed, updates would be included in January 2017 through March 2017 rates

FY2016-17 RATE UPDATE CONSIDERATIONS CFCO

- Effective January 1, 2017, MLTC plans will be required to expand and/or enhance the benefit package to include services and supports within the Community First Choice Option (CFCO)
- CFCO updates are scheduled for January 1, 2017 and will impact January 2017 through March 2017 rates
- Utilization of these services for similar populations and programs will be reviewed to inform the program change adjustment for these services
