
Managed Long Term Care (MLTC) and Fully Integrated Duals Advantage (FIDA) Update

MLTC Statewide Enrollment*

Number of Plans Statewide Actively Enrolling: 65

Total Enrollees Statewide: 165,612



Conflict-Free Evaluation and Enrollment Center (CFEEC) Activity as of May 1, 2016

- The CFEC is operational throughout the state and evaluations have occurred in all counties.
- Average call volume is 833 per day.
- 148 nurses are on staff to handle the volume.
- 76,794 evaluations conducted to date:
 - √98% approval rate
 - √2% denial rate



Community First Choice Option (CFCO) Update

- DOH is moving forward with the operationalization of CFCO, which was approved on October 23, 2015, with a retro-active effective date of July 1, 2015.
- In April, Commissioners received letters informing them that New York State is participating in CFCO, which became available under the Affordable Care Act.
- CFCO incorporates enhanced personal attendant services and supports into the Medicaid State Plan for eligible individuals who need help with everyday activities due to a physical, developmental or behavioral disability.
- An Administrative Directive Memorandum (ADM) was drafted to outline the scope and procedures of CFCO services.

Community First Choice Option (CFCO) Update

- The ADM was shared with the Development & Implementation Council and contacts at OPWDD, OMH, OPCHSM, MA Eligibility, and some LDSSs last week.
- Following a comment period, the ADM will undergo further editing before a final copy is released.
- The finalized ADM will help local districts understand their roles and responsibilities with implementing CFCO, specifically how these services and supports will be accessed and authorized.
- Initiating internal discussions on bringing benefits into MLTC.



MLTC Update

- A Dear Administrator Letter (DAL) was released about guidance on licensed and unlicensed housing settings. The letter outlined differences between unlicensed and licensed options for various long-term care residences in New York State.
