PACE Proposal Overview

OVERVIEW

CMS approved the use of \$40M of ARPA HCBS enhanced FMAP funds to assist the 9 PACE organizations in New York with reopening safely, building qualified workforces, and growing the PACE program.

How Will Funding Be Distributed?

STATE

\$40MTOTAL FUNDING

9 PACE Organizations







DOH will distribute \$40M directly to the 9 PACE organizations in the State as lump sum payments

- Half of the funds (\$20M) will be distributed equally across all PACE organizations
- Half of the funds (\$20M) will be **distributed proportional to the number of PACE centers** operated by each PACE organization

Responsibilities and Timeline


KEY RESPONSIBILITIES



NYS will collect attestations and finalize funding amounts to distribute to PACE organizations



PACE organizations must attest that they will spend funds on appropriate uses and that they will spend the funds before March 31, 2024. NYS will only provide funds from this initiative to PACE organizations that attest to these requirements.

Spending Considerations

KEY GUIDANCE

- PACE organization may only use their awards to fund one or more of the following items and activities:
 - 1. Investments in the Workforce
 - 2. Site Reopening and Infrastructure Upgrades
 - 3. Growing the PACE Program
- Funds cannot be used to pay for awards, benefit programs, or salary increases for administrative staff, managers, and executive staff. Funds cannot be used to support current wage levels, including overtime, for any employees.
- Funding cannot be used to supplant current or already planned expenses.
- PACE organizations must spend all funds by March 31, 2024.



How Must Providers Spend Their Awards?

Workforce Recruitment and Retention Investments

Examples include:

- Employee recognition and retention activities
- Employee development and training initiatives
- Enhanced employee benefits
- Employee recruitment efforts

Site Reopening and Infrastructure Upgrades

Examples include:

- Purchasing PPE
- Educating staff about COVID-19 vaccination and testing
- Renovating / improving PACE centers for infection prevention
- Installing symptom screening devices

Growing the PACE Program

Examples include:

- Expanding capabilities for telehealth and telemedicine
- Increasing outreach and education
- Expanding capacity to address social determinants of health and health disparities

Comprehensive spending guidance will be provided to PACE organizations shortly.



Next Steps

- NYS will send attestations to PACE organizations this week.
- PACE organizations will have until March
 17, 2023 to submit attestations to maintain eligibility for funding.
- NYS will issue funds to PACE organizations targeting May 2023.
