Attention: Mainstream Medicaid Managed Care Plans (MMC plans), HIV Special Needs Plans (HIV SNPs), Health and Recovery Plans (HARPs) and Medicaid Advantage Plus (MAP) Plans.

Regarding: Rate Increase for OASAS Services – effective 1-1-23

The New York State (NYS) Division of the Budget has approved Medicaid rate package(s) to establish new levels of reimbursement for the following Office of Addiction Services and Supports (OASAS) programs:

- OASAS Part 822 Outpatient Addiction Services, both freestanding and hospital; including Clinic, Outpatient Rehabilitation, and Opioid Treatment Programs (OTPs).
- OASAS Part 820 Residential Services: Stabilization, Rehabilitation, Reintegration.
- OASAS Part 818 Freestanding Inpatient Rehabilitation.
- OASAS Part 816 Freestanding Inpatient Withdrawal and Stabilization.
- OASAS Part 817 Residential Rehabilitation Services for Youth.

This notification provides information on the changes to each program type along with the new rates. The rate requirements apply not only on a prospective basis, but are, in fact, also required as per NYS law (Public health law section 4403-f (7)(k) and Social Services Law §364-j (18)(e)) to be retroactive to the effective date of any rate change. The plans will be given 90 days from the date of this notification to update the rates. Prompt pay penalties will be determined per State Insurance Law (SIL) § 3224-a.

- 21.44% increase to Downstate Stabilization effective March 1, 2023
- 15% increase to Upstate Stabilization Rate effective March 1, 2023
- 4.5% increase Upstate and Downstate Rehabilitation effective March 1, 2023
