October 2015 Rate Components

• The October 2015 premiums contain the following changes from April 2015:

Component	Description
Behavioral Health (BH) Add-On	Effective October 1, 2015, full BH benefit for adults age 21 carved into MMC rates for NYC Metro. Benefits include: • new BH services (PROS, ACT, IPRT, etc.) • all inpatient/outpatient BH benefits for SSI enrollees
HARP Population Adjustment	MMC rates adjusted to account for the transition of eligible members from current premium groups in the NYC Metro region into HARPs beginning October 1, 2015 * The Department is aware of the diminished phase in of HARP eligible enrollees to HARPs and will be evaluating the impact for future MMC rate updates
Pharmacy	\$50M pharmacy investment for the following initiatives: • \$30M for encounter data reporting compliance • \$20M for "high cost" drug pool
Transgender Services	Effective March 11, 2015, coverage required of transition-related care and service for persons diagnosed with Gender Dysphoria: Cross-sex hormone therapy Gender reassignment surgery
FLSA	Adjustment to comply with changes related to the Fair Labor Standards Active (FLSA). Among these changes are revised overtime, travel time, and live-in worker reimbursement standards
HCRA/CLA	Update to the April 2015 HCRA/CLA adjustment on the TANF Adult – Aliessa rate cell

Impact of Oct 2015 Rates

• The statewide average October 2015 preliminary percent increase from the April 2015 pmpm premiums is 0.5% for Medicaid Managed Care. The chart below shows the breakout of the impacts:



HARP Population Carve Out	(1.3%)	Reflects transition of HARP eligible members to HARP in NYC
Transgender	0.0%	Includes adjustment for new therapies
FLSA	0.0%	Adjustment to comply with changes related to Fair Labor Standards Act (FLSA)
Other	0.1%	Reflects adjustments to new populations/benefits for HARP transition
