DSRIP and 1115 Waiver Programs

- Final PPS Year 1 Third Quarterly Reports were posted to the DSRIP website.
- The All-PPS in person meeting was held in Albany, on Friday, April 8th. All presentations are now posted to the DSRIP website.
 - MCO and Equity updates,
 - DSRIP Y3 midpoint assessment process starts this summer
 - Prevention Agenda dashboards
 - Behavioral Health Integration models led by Mt Sinai panel members.
- The downstate Public Comment Day on New York's 1115 Waiver programs will be held on May 4th in New York City and the upstate Public Comment Day will be held on June 10th in Albany. These meetings will be webcast live and will be open to the public.

Combined MCO Medical Directors' and DSRIP Chief Medical Officers' Meeting

- First combined meeting of the Health Plan Medical Directors and DSRIP Chief Medical Officers held yesterday, 4-13-16, in NYC.
- Excellent participation and enthusiasm.
- DSRIP Dashboards presented by Salient's John Amisano
- Other presentations included:
 - NY State's smoking cessation efforts and relationship to DSRIP projects
 - HIV Pre-exposure Prophylaxis (PrEP) as part of Governor's Campaign to End AIDS, and relationship to DSRIP HIV projects
 - NY State Medicaid topic updates

Opt Out Update

- Opt out 5.6 million letters sent
- < 2% formal opt out
- Larger % by default due to undeliverable/bad address
- Monthly process to begin in May to newly eligible
- Opt outs removed from:
 - PPS Member rosters
 - MCO Member rosters flagged with attributed PPS
 - PPS Comprehensive Provider Attribution lists
 - PPS Claims/Encounter Extracts
 - DSRIP Dashboard (included in aggregate but not PHI drill down)
 - PPS Individual Provider Attribution lists (are aggregate only)

Outstanding MCO Issues

- Managed Care Plan user access and provisioning roles to the DSRIP performance dashboards in development. Pending DEAA requirements to be issued by Caryl Shakshober, DOH privacy office.
- Mental Hygiene data sharing question from the plan meeting held on January 21, 2016 is being addressed through interagency (DOH/OASAS/OMH) legal collaboration.
- Managed Care Plan Member Attribution rosters flagged by attributed PPS will be minus those who have opted out. Pending for May per opt out wrap up.
- Equity Payments and contracting
