- Nursing Home Transition and Diversion Waiver
- Personal Care
- Traumatic Brain Injury Waiver

Managed Long Term Care Plans	Full transition to UAS-NY October 1, 2013

- Release Notes and Resolved Bugs
 - Thoroughly Tested Application
