RE: NYC Wage Parity Rates Effective March 1, 2014 for Certified Home Health Agencies

Dear Administrator:

This letter is to inform you of revisions to the Medicaid rates for Certified Home Health Agencies (CHHAs) located in New York City effective March 1, 2014 in accordance with Section 3614.14 of the Public Health Law (PHL). These rates provide an adjustment to address cost increases resulting from wage increases required by implementation of the provisions of the wage parity law in PHL 3614-c.

In accordance with PHL 3614.14, the Department has determined an adjustment to the pediatric fee-for-service rates for New York City CHHA providers to establish a total minimum rate for home health aide services of \$20.95 per hour, retroactive to March 1, 2014. Episodic payment rates for New York City agencies have been increased by 11.52% to reflect the estimated increase in home health aide wages under the wage parity provisions compared to the 2009 base year. Calculation of the episodic adjustment is attached.

These revised rates have been transmitted to the Department's eMedNY system for payment processing. A copy of the revised Medicaid rate computation sheets, reflecting the increase, if applicable, of your bottom-line Medicaid home health aide rate to \$20.95 effective March 1, 2014 through December 31, 2014, is now available on the HCS website. Revised episodic rates for New York City providers also are available on the HCS site.
