Learn the new code...

On October 1, 2015, the ICD-9 code sets used to report medical diagnosis and in-patient procedures will be replaced by ICD-10 code sets. This presentation will familiarize staff responsible for coding with the organization and structure of the new code set and the similarities and differences between ICD-9 and ICD-10.

Program objectives

1. Apply the basic characteristics, conventions, and guidelines of the ICD-10-CM classification system when coding and reporting diagnoses;
2. Identify and accurately assign ICD-10-CM to diseases and conditions using the coding book;
3. Identify documentation practices within long term care affected by the transition to ICD-10-CM; and
4. Identify potential areas of concerns with usage of GEMs mapping during transition to ICD-10-CM.
