

## 65 and Older Medicaid Enrollee Counts, by Region, by MCO and Type: January 2013

This document presents counts of Medicaid enrollees age 65 and over as of January 2013 by state Economic Region. Counts are provided by eligibility: Medicaid-only and Medicaid-Medicare ("dual eligibles"). The document shows how many individuals are in Fee-for-service Medicaid, how many in Medicaid managed care. For those in managed care, the plan type and organization is shown. This data provides important insight into the organizations and plan types that are strong players in each region and can serve as a reference for providers interested in contracting with managed care plans.
