FIDA Update

- ❑ After a review of the plans' readiness for the FIDA Demonstration, DOH and CMS agreed to adjust the start date to January 1, 2015.
- ❑ Individuals in Bronx, Kings, Nassau, New York, Queens, and Richmond counties will be able to join the FIDA Demonstration on January 1, 2015.
 - ❑ Passive enrollment will be phased in beginning April 1, 2015.
- ❑ Individuals in Suffolk and Westchester will be able to join the FIDA Demonstration no earlier than April 1, 2015.
 - ❑ Passive enrollment will begin no earlier than July 1, 2015.
 - ❑ Suffolk and Westchester delayed 6 months to cure remaining network deficiencies.

FIDA Update

❑ Three-Way Contract:

- ❑ Sent to Plans for their signature on 6/19.
- ❑ Plans returned electronic signatures on 7/9 and original signatures on 7/11.
- ❑ 22 Plans submitted signed contracts and will continue with the readiness review process.

❑ Pre-enrollment tool validation reports:

- ❑ CMS sent the pre-enrollment validation findings to Plans on 7/10.
- ❑ Plans have until 8/15/14 to re-submit the tool to CMS and address any deficiencies.

FIDA Demonstration Deliverables

Plans return signed Three-Way Contracts:

- Electronic signature pages due July 9, 2014
- Hard copy original signature pages due July 11, 2014

CMS sends pre-enrollment validation tool findings to Plans July 11, 2014

Additional required marketing templates will be released with due dates indicated at the time of release. Other discretionary marketing documents (e.g., bus and subway ads) may be submitted and approved on a rolling basis. July - September 2014

Plans re-submit pre-enrollment validation tool, addressing any remaining deficiencies, to CMS August 15, 2014

CY 2015 PBP and ADD Files approved by NY and CMS Mid-August 2014

FIDA Update

❑ Enrollment:

- ❑ The draft Enrollment Companion Guide was released to Plans on 7/7 and comments were due back on 7/14. The companion guide will then be finalized and issued to Plans.
- ❑ Enrollment notices – Notice development is underway and has been an iterative process involving consumer focus group testing as well as Plan and advocate comment periods. As development continues, additional notices will be sent out for stakeholder comment.
- ❑ The State specific Enrollment Guidance is in draft and will be issued to plans by the end of August.

FIDA Update

❑ Marketing:

- ❑ 30-day marketing activities will begin December 2014.
- ❑ All marketing materials (required templates and other discretionary materials) need to be approved by November 1, 2014.
- ❑ The remaining 8 required template chapters as well as the template ID card will be sent in the beginning of September.

FIDA Update

- ❑ Encounter Data:
 - ❑ The integrated process for encounters submission is still in development.
 - ❑ For year 1 of the Demonstration, Plans will be required to submit both Medicaid and Medicare encounter data, including Pharmacy claims, to both the State and CMS.
- ❑ Reporting requirements are in development.

MLTC Update

- ❑ Letters went out to consumers and in the following counties on June 30, 2014:
 - ❑ Greene,
 - ❑ Schenectady,
 - ❑ Washington, and
 - ❑ Saratoga.

MLTC Update

- ❑ The State has not yet received CMS approval for the following counties:
 - ❑ **July 2014:** Dutchess, Montgomery, Broome, Fulton, Madison, Schoharie, Oswego
 - ❑ **August 2014:** Warren, Delaware, Niagara, Otsego, Chenango
 - ❑ **September 2014:** Essex, Clinton, Franklin, Hamilton

MLTC Update

- ❑ Network information was requested and sent to CMS for the July districts.
- ❑ Staff are well into the planning process with the July counties and starting the planning process with the August counties.
- ❑ Once we have CMS approval the announcement letters begin and we work with the counties to determine the exact date to 'shut the front door'.

MLTC Update

- ❑ The State convened a call on 6/30/14 for the remaining counties which include.
 - ❑ **September 2014:** Essex, Clinton, Franklin, Hamilton
 - ❑ **October 2014:** Jefferson, Lewis, St. Lawrence, Steuben, Chautauqua, Cattaraugus, Alleghany
 - ❑ **November 2014:** Yates, Seneca, Schuyler, Tioga, Cortland, Chemung
 - ❑ **December 2014:** Genesee, Ontario, Livingston, Orleans, Tompkins, Wayne, Wyoming
