2014 Mandatory Rates Summary

- Premium base medical for NYC Region is \$3,551.
 - mix of NHC/Non–NHC set to 90/10
 - Managed Care savings of 23.71%
- Projected cost profile for NYC Region is \$3,363.
 - mix of NHC/Non-NHC in 2013 encounter data is 70/30 based on PMPM cost profile (see table on slide 4)
 - Managed Care savings of 23.71%
 - an increase of 3.31% from 20.40% in 2013
- Care management component is \$228.
 - 2013 Partial Cap cost reports for NYC is \$219

Rate Packages Key Decisions

- No changes:
 - 2014 mandatory rates remain as is
 - 2015 FIDA rates remain as is
- Implement the change to the Medicare Savings adjustment to exclude Part D effective in 2014 PACE premium rates.
- No 2012 Risk Corridor Settlement and do not recoup the \$3.4M from Plans.
- Commit to an additional \$10M of new money in 2015 MLTC rates to support admin related to NH transition (with MMC).
- The State will pursue establishing a fund pool in FIDA to support implementing shared savings (new money).
