## **Leading Age New York in 2023**

With robust, year round advocacy, education and outreach efforts, we secured the largest Medicaid rate increase for nursing homes, assisted living programs and adult day health care in recent memory. We monitored over 900 pieces of legislation and took action on more than 50 bills that could impact our members. With our dedicated efforts to energize our advocacy network, we collectively sent nearly 26,000 letters to State elected officials communicating our member's priorities and positions on legislation.
