

LeadingAge New York Art Competition & Exhibit 2014 Call for Artwork

LeadingAge New York is accepting entries for its 2014 Art Competition and Exhibit. **All entries must be received no later than Feb. 24, 2014.**

The Art Exhibit is back on the road this year!!

The 2014 LeadingAge NY Art Exhibit and Competition is being sponsored by [Spring Line Design Architecture & Engineering](#) and we are looking for up to five facilities to host this year. If you are interested in being a host facility please take our short facility host survey by [clicking here](#) and you will be entered into the pool of candidates. Facilities chosen to host the LeadingAge New York Traveling Art Exhibit will be notified by the end of February.

The top 70 paintings will also be on display at our Housing Conference in March, Annual Conference & Exposition in June and the DNS/DSW conference this fall. The exhibit will be available virtually on the LeadingAge NY website and our Facebook page. Between conferences and hosting sites, the Art Show will be on display in LeadingAge NY's office. As in years past, we will continue to have a Best in Show, Honorable Mention and Merit Award winners.

Every piece of art work received will be a winner! For works that are not chosen to be part of the top 70 we will be having our Staff Choice Awards (painting chosen by a LeadingAge NY employee to hang in their office while the exhibit is on display) and our Gallery Awards (painting chosen to be hung in the public areas of our offices).

Attached are two forms that must be submitted with each piece of art. The first is a biographical sketch of the artist and the second is a release form.

Submission Criteria

- Art may be in any two-dimensional form (painting, watercolor, photograph, woodcut, woodcarving, etc.). We **cannot accept** sculptures or freestanding, three-dimensional pieces.
- Artwork must be framed and ready to hang. If the piece is not framed, it will be ineligible for competition and will be returned immediately.
- All art pieces must not exceed 36" x 24" (horizontal or vertical). We **cannot accept** works of art any larger than these dimensions.

We have two categories for artists, and artwork will be divided into these two categories prior to judging:

- Residents/clients/registrants of LeadingAge New York or ADHCC member organizations or programs.
- Staff or volunteers of LeadingAge New York or ADHCC member organizations or programs.

Due to space constraints, we can only accept one entry per participant. Multiple entries will not be accepted. Artwork by residents must have been done since he/she was associated with the LeadingAge NY/ADHCC member. For example, we cannot accept a piece done in 1956 when the person was 20 years old and living on his/her own. However, if the resident/client/registrant is a young person living, working or volunteering in a LeadingAge NY/ADHCC facility, we encourage their participation.

The deadline for accepting entries is Feb. 24, 2014. We cannot accept anything after the deadline.
