ABSTRACT: New DALs on management contracts, ACF census.

The Department of Health (DOH) has posted two new *Dear Administrator* letters (DALs) for Adult Care Facilities (ACFs). The second DAL reminds providers that the ACF Annual Census Report was due on January 31, 2008.
