ABSTRACT: NYAHSA advises members on Part B rates for Jan/Feb 2010.

Introduction

The president has signed legislation that provides a temporary override to the 21.2 percent reduction to 2010 Medicare Physician Fee Schedule (MPFS), including nursing home and home health agency therapy and ancillary Part B services. The override is effective from 1/1/2010 to 2/28/2010.

CMS has instructed its contractors to hold claims for services paid under Part B for up to the first 10 business days of January (January 1 through January 15) for 2010 dates of service. This should have minimal impact on provider cash flow because, by law, clean electronic claims are not paid any sooner than 14 calendar days (29 days for paper claims) after the date of receipt. Meanwhile, all claims for services delivered on or before December 31, 2009, will be processed and paid under normal procedures.

The holding of claims allows Medicare contractors time to receive the updated payment files (i.e., the frozen 2009 rates) and perform necessary testing before paying claims at the frozen rates. CMS has instructed contractors to begin processing claims at the frozen rates **no later than** January 19, 2010. NYAHSA is closely monitoring the situation and will advise members of any developments as additional steps are in process for a potential permanent override to the cuts.

January and February Rate Adjustments

Despite the freeze, for the first two months of 2010 CMS has made minor adjustments to the relative value units of some rates and the conversion factor (CF). For January and February, the CF increases from \$36.0666 to \$36.0846, and this adjustments impacts all rates. An average, the impact on individual rates should be relatively small.

For member convenience, a copy of the adjusted rates for some of the most common procedures and physician evaluation and management (E&M) codes for the freeze period are attached (see Tables 1 and 2 respectively). This in not meant to be a comprehensive listing of all billable codes and there may be additional codes for which a provider may be reimbursed. NYAHSA cautions that there are often some errors in the first run of the fee screen amounts and that CMS will likely publish corrections in its quarterly updates. The attached lists of fee screen amounts are divided into five sections, representing different localities in New York State. The corresponding counties for each payment locality are listed below.

Part B rates for the remaining 10 months of CY 2010 will depend upon final action by Congress. NYAHSA will issue a more comprehensive analysis of the Part B rates once Congress acts on this issue. Members are also reminded that the therapy caps exceptions process expired as of 12/31/2009 (see Doc. ID # n00004143 referenced above). NYAHSA and AAHSA continue to advocate on these critical matters.
